### TERMS AND CONDITIONS

- 1/ Shotokan Karate Do International Organization Right of Admission.
- 2/ A compulsory attendance of 8 classes a month is essential. Failing which He/She shall not be eligible for the periodical grading tests.
- 3/ Students shall not demonstrate, practice or technique this Martial Arts outside the karate organization, in the absence of his/her Chief Instructor or without the direct supervision of senior deputed by the Chief Instructor either in place where such classes of instruction conducted or outside.
- 4/ The instructor or the chief instructor shall not be either involved or referred to in any complaint to the police or otherwise in the event of any student directly or indirectly has acted in or have used the techniques of karate either alone or in organization with others to cause subversion of place of society or cause pain. or injury/invalidity of temporary or permanent nature to any individual or public property.
- 5/ The institute/instructor shall not be responsible for any accident before, during after or training.
- 6/ The monthly fees should be paid within 10th of each month.
- 7/ Students and members are not permitted to join any other karate institute without getting no objection certificate/letter from the headquarters.If does, it may lead to cancellation of all previous belt grading.
- 8/ In the event loss to the member seeking admission Shotokan Karate Do International Organization in any of the branches of affiliated centres, it shall not implicate or involve either in civil or in criminal case the instructor, or the president & chief instructor or the management of such branch or centre.  
This clause is made specific for the reason that this Martial Arts of karate inherently carrying the risk of life can not be ignored.
- 9/ In case of any unavoidable or circumstances under risk, the training must continue online/offline. The change in the mode of learning will not be accepted as an excuse to discontinue the training.
- 10/ Discipline is a must for learning all the martial arts. If any student is violating the standards norms of following rules and regulations, it will cause an immediate termination from the institution and cancellation of previous belt gradings.
