## TERMS AND CONDITIONS FOR MEMBERSHIP

Duties for the post of state chief/ style chief would be following.

1. He/She must and should organize one state championship in his/her state within a 1 year.
2. He/She will be responsible for the complete accommodation and travelling of chief instructor/president/special faculty (national/International) attending any state championship, seminar, belt exam, etc. All the expenses of chief instructor/president/Grandmaster for example stay, travels, food, etc. should be taken care by the state chief.
3. Application for appointment of Chief instructor/President/Special faculty (national/International)/Grandmaster must be requested minimum one month ago in written or else it will be considered as immediate appointment which is eligible for rejection or extra charges.
4. For TSKU & OITK members to participate in other organization's championships/events, it is compulsory to get NOC from the HQ of TSKU & OITK. One can participate only after receiving NOC in written. Application for NOC must be done in minimum one month advance.
5. It is compulsory to get minimum one hundred KYU certificates every year and should conduct championships as well as seminars. In case of failure, the state chief has to write an explanation letter to the president. If the explanation would not be found suitable by the president, it may result in demotion of the post or permanent termination without any notice and or returning of any payment done to TSKU & OITK.
6. TSKU & OITK HQ can extend its branch in all the states and can give membership to others as well. The state chief is bound to admit and obey this. General rules and regulations.
7. Each and every instructor of TSKU & OITK must attend all the national and international matches organized by TSKU & OITK. If any medical/other emergency arises, one needs to submit all evidences to support the cause. Submission of any in-valid or illegal certificates or statements will be subject matter to legal actions.
8. For resigning from TSKU & OITK and joining other organization, NOC from TSKU & OITK is a must. Application for NOC against resignation is to be done minimum three month.
9. All the members of TSKU & OITK should acknowledge, share and comment actively on each post in the WhatsApp group and Facebook page of TSKU & OITK. Everyone will share their ideas and thoughts in this platforms at their best on how to extend and improve TSKU & OITK.
10. Every national, state, District, dojo, championship certificates will be given by the HQ of TSKU & OITK directly. The state chief/any other authority cannot print certificates by his/her own and if they do, it will result into penalty charges along with immediate termination without any advance notice.
